Delaware Coalition for Open Government Virtual Board Meeting by Zoom Tuesday, November 7, 2023

CALL TO ORDER: John Kowalko III called the meeting to order at 6:33 p.m.

ORDER OF BUSINESS

- 1. **Introduction:** John Kowalko III welcomed board members, DelCOG members and guests.
- 2. **Meeting Minutes**: A motion to approve the Board meeting minutes of October 3, 2023, with one correction, was seconded, and approved unanimously. The corrected minutes will be sent to the board again.
- **3. Treasurer Report:** Anita Rush reported an anonymous donation of \$2,000 to DelCOG during October that was deposited into the savings account and reimbursement, and checks paid to J. Kowalko III for Zoom renewal and registrations fees for board members to attend the NFOIC Summit.

The current balances in the checking and savings accounts:

WSFS checking account balance as of October 31, 2023, was \$3,263.99.

WSFS savings account balance as of October 31, 2023, was \$7,785.17.

Total account balance as of September 30, 2023, was \$11,049.16.

The Treasurer's report was accepted and filed.

COMMITTEE REPORTS:

1. Inspector General Chapter Committee: Nick Waseleski assured board members that there definitely will be an IG bill and Kowalko Sr. will follow up with Sen. Sturgeon to have it prefilled in December.

Flaherty noted that the governor's budget hearings will commence shortly, and he will send out the calendar to board members. Wasileski will work on testimony for the hearing. DelCOG Legislative Committee will meet before the budget hearings.

- 2. Inspector General Book Chapter Committee: Katherine Ward and Wasilewski have gone through the footnotes again and still are doing small revisions towards the end of the chapter, then sent it to Kowalko III and then to Robin and the publisher. A huge thank you to Wasileski, Ward and Kowalko III from the Board.
- **3. FOIA Committee:** John Kowalko. III announced the committee will meet in December to figure out what DelCOG's priorities can be for the coming year..
- **4. LLC Committee Updates:** Nick Wasileski reported that in January 2024, the Federal Corporate Transparency Act will go into effect. This requires Beneficial Owners to report to the Federal Treasury if they own 20% of the corporation. Wasileski was thanked for his tremendous work for many years to get this accomplished.
- **5. Annual Meeting Planning:** Cynthis Smith reported that the committee met and has everything ready to go out to the membership and the public as well as the flyer. Annual meeting details are listed at the end of these minutes. She asked that all of us post the event on social media and invite friends as well, so we get a good attendance.
- **6. Bylaws and Procedures Committee:** John Kowalko III reported that the committee will meet to review the bylaws to clarify when the appointment of directors to the board should take place.
- **7.** Website Committee: John Kowalko III and Katherine Ward now have access to the new website that is being updated. He noted that our domain still needs to be pointed to Dream Host. Our webmaster is our domain registrar (Katherine Ward).
- **8. Nominating Committee:** John Flaherty has sent a request for nominations to the membership. (email and forms are listed at the end of these minutes). He has not received any nominations from the membership. The committee is putting the following nominations to the board:

A motion to accept the nomination was moved, seconded, and passed unanimously.

UNFINISHED BUSINESS

- 1. Lead Free Delaware Update: Wasileski reported that DelCOG had voted to sign onto the letter that was sent to the EPA with a copy to our congressional delegation who also signed onto this letter. The letter was part of the October minutes. It was noted that Amy Roe and Sarah Busic did some fine work on this issue.
- 2. Police Radio Encryption No report..
- **3. Organizational Development**: Kowalko III has collected nearly all the legal documents he needs.

- **4.** New Castle County Property Maps John Flaherty noted that he has no update on this issue, and this should be taken off the agenda because the issue has been taken care of.
- **5. NFOIC Summit:** John Kowalko III noted that the videos of the summit are still available on the site, and some are posted on Facebook.
- **6. Delaware Legislative Issues Report:** Flaherty noted that he has no additional information, but it is important to have meaningful interaction at the Governor's Budget Hearings. Usually, organizations get five minutes for a statement and individuals get three minutes to testify at these hearings.

NEW BUSINESS

1. Sunset Committee Process Questions: Cynthia Smith asked how the process works. Flaherty responded that this committee is meeting now and has sent out a list for 2024 of agencies they will review. They will review 5-6 agencies each legislative session and the public can lobby the committee to suggest agencies for review.

OPEN FORUM

Flaherty has received an email from Sam Waltz who would like to meet DelCOG board in person.

Coralie Pryde discussed the Delaware River Basin Commission and some proposed changes of some regulations that will affect the public to get access and comment on proposals. The staff will do more of its work in the shadows and the system will not be transparent to the public.

Nick Wasileski announces that the audit review of the DelCOG books will be done by J. Kowalko and N. Wasileski.

The next meeting will be the annual meeting on Wednesday, December 6 at 7 P.M. 20023. by zoom.

As legislative counsel for the New York City Council, she drafted and negotiated legislation regarding procurement of goods, services, and construction, and coordinated Council oversight of city agencies.

She also clerked for the Hon. John C. Lifland (ret.) in the U.S. District Court for the District of New Jersey and later served as a litigation associate at Davis Polk & Wardwell LLP. She earned an A.B. from Harvard College and a JD from Harvard Law School.
